## Plant Therapy™ Instructions

- 1) Please collect leaf samples, **from one species only**, according to standard crop procedures (call for details) and deposit them in a paper bag.
- 2) The information sheet below must be completed and sample bags should be labelled with your name and sample ID.
- 3) **Express post** the samples in an envelope, and include credit card details or a cheque for payment made out to **Environmental Analysis Laboratories. Include completed EAL Client Registration Form.**
- 4) **Note:** It is essential to express post samples in an overnight bag, or use airmail to ensure the sample arrives as soon as possible.
- 5) It is acceptable to send plant matter to a certified laboratory within Australia. Australia Post are not authorised to act as quarantine agents as we have already established a ruling on this matter.
- 6) **Environmental Analysis Laboratories** will email results directly to us or your local distributor within 4 to 5 working days of receipt of your samples.
- 7) The results will be incorporated into a comprehensive **Plant Therapy™** analysis sheet, which will clarify your results, and relevant recommendations will be provided.
- 8) If you are sampling an unusual or not well-researched crop, please check with our agronomy department first to confirm whether the data for analysis is available.
- 9) Your **Plant Therapy™** report will be faxed or emailed to you ASAP.
